ORDINANCE NO. 2014-08 (1133)

AN ORDINANCE OF THE BOROUGH OF LAVALLETTE, IN THE COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE CODE OF THE BOROUGH OF LAVALLETTE TO ADJUST THE FEES CHARGED FOR USE OF BEACHES AND FACILITIES.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Lavallette, in the County of Ocean, State of New Jersey, as follows:

SECTION 1. § 7 of the Code of the Borough of Lavallette, entitled "Bathing and Beach Control" is hereby amended and supplemented to revise the fee schedule for the sale of beach badges. Section § 7-9A(1) through (5) shall read in its entirety as follows:

§ 7-9. Fees for use of beaches and facilities.

A. In order to provide funds to improve, maintain and police said places of resort, protect the same from erosion, encroachment and damage by the sea or otherwise and provide facilities and safeguards for public bathing and recreation, including employment of lifeguards and the purchase and maintenance of rescue and first-aid equipment, the following registration fees shall be charged and collected for the use of the oceanfront and bayfront beaches, bathing and recreational facilities of same:

- (1) No fees shall be charged or collected from any person under the age of 12 years for a beach badge for the use of the beaches and bathing facilities.
- (2) For each daily badge: ~~\$8~~ 7.
- (3) For each weekly badge: \$25. A "week" is defined as the period from Saturday through the following Saturday.
- (4) For each full-season badge: \$45.
 - (a) For each full-season badge: For any person who is 65 years of age or older: \$14.
 - (b) For persons who meet the disability criteria for disability benefits under Title II of the Federal Social Security Act: \$14.
 - (c) For all disabled veterans of any military service and all military service personnel on active duty status: \$14.
- (5) A two percent (2%) fee will be added to the price of each badge purchased when the

purchase of the badge(s) is made through the use of a credit / debit card. Credit cards include Master Card, Visa, and Discover.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portion hereof.
