

ORDINANCE NO. 2014-09 (1134)

AN ORDINANCE OF THE BOROUGH OF LAVALLETTE AMENDING CHAPTER 89 OF THE GENERAL ORDINANCES OF THE BOROUGH OF LAVALLETTE, COUNTY OF OCEAN, STATE OF NEW JERSEY ENTITLED "VEHICLES AND TRAFFIC" TO MODIFY THE TIME PERIOD THAT PARKING STICKERS ARE REQUIRED IN THE MUNICIPAL PARKING LOTS.

BE IT RESOLVED by the Mayor and Council of the Borough of Lavallette, County of Ocean, State of New Jersey, as follows:

SECTION 1. ARTICLE IIIB of Chapter 89 "VEHICLES AND TRAFFIC" of the Code of the Borough of Lavallette, entitled "**Sticker Required**" is hereby amended and supplemented to modify the time period that parking permits are required in the Municipal Parking Lots. Section § 89-10A shall read in its entirety are follows:

ARTICLE IV  
Municipal Parking Lots

§ 89-10. Sticker required; fee.

- A. No person shall enter or park a motor vehicle, as defined by N.J.S.A. 39:1-1 et seq. (New Jersey Motor Vehicle and Traffic Regulations), in Municipal Parking Lot Nos. 1, 2, 3 or 4, during the bathing season as established in § 7-9B ~~from the Friday of Memorial Day Weekend through Labor Day~~, unless said motor vehicle shall bear a sticker of the current year issued by the municipality. Each motor vehicle shall bear a separate sticker which shall be permanently affixed to the driver's side rear window. A vehicle which has no driver's side rear window shall have the sticker permanently affixed to the left side of the vehicle body. A fee of \$10 shall be charged for each sticker issuance.

SECTION 2. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.
