

**ORDINANCE NO. 2014-11 (1136)**

**ORDINANCE OF THE BOROUGH OF LAVALLETTE, COUNTY OF OCEAN,  
STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 25  
OF THE BOROUGH CODE, ENTITLED "FEES" SO AS TO MAKE THE FEE  
FOR THE USE OF MUNICIPAL PAVILIONS AND GAZEBOS NON-  
REFUNDABLE.**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Lavallette, in the County of Ocean, State of New Jersey, as follows:

**SECTION 1.** § 25 of the Code of the Borough of Lavallette entitled "Fees" is hereby amended and supplemented to make the fee for the use of the municipal pavilions and gazebo non-refundable. Section § 25-1A of the Borough Code is hereby amended to read in its entirety as follows:

§ 25-13 Gazebo and Pavilion Fee. No person, group or organization shall use any municipal Gazebo or Pavilion for a private function such as a wedding or other event without paying a fee to the Borough.

A. The following Gazebo and Pavilion Fee is hereby established. For rental or use of any municipal Gazebo or Pavilion for private or non-profit functions, \$200.00 non-refundable fee per event per day or portion thereof. ~~In the event that the function is canceled, the person, group or organization shall be entitled to a refund of \$175.00 upon written application to the Chief Financial Officer.~~

**SECTION 2** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 3.** All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4.** This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.


Said Ordinance was duly adopted on the 22nd day of December, 2014 and shall take effect upon publication as required by law.
