

ORDINANCE NO. 2016-09 (1153)

AN ORDINANCE OF THE BOROUGH OF LAVALLETTE, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 90, ENTITLED "ZONING" OF THE CODE OF THE BOROUGH OF LAVALLETTE AMENDING ZONING PERMIT FEES

BE IT RESOLVED, by the Governing Body of the Borough of Lavallette that Chapter 90, § 90-79 C., be repealed in its entirety and supplemented in its entirety to read as follows:

§90-79. Certificates and Permits.

C. Zoning Permit application fees.

- (1) A nonrefundable zoning permit application fee of \$200 for new construction or accessory structure shall be submitted, payable to the Borough of Lavallette.
- (2) A nonrefundable zoning permit application fee of \$150 for additions or House Lifts, payable to the Borough of Lavallette.
- (3) A nonrefundable zoning permit application fee of \$250 for the installation or modification of a bulkhead, payable to the Borough of Lavallette.
- (4) A nonrefundable zoning permit application fee of \$100 for interior remodeling, payable to the Borough of Lavallette.
- (5) A nonrefundable zoning permit application fee of \$25 for pavers, fence, roofing, siding, and windows, payable to the Borough of Lavallette.
- (6) A nonrefundable zoning permit application fee of \$50, for curbing, sidewalks and all other, payable to the Borough of Lavallette.
 - (a) The name and address of the workman or contractor who is to perform the work.

NOW, THEREFORE BE IT RESOLVED, that the fees set forth above are hereby established.

BE IT FURTHER RESOLVED, if any section, paragraph subsection, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subsection, and clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

BE IT FURTHER RESOLVED, all ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed as to such inconsistency.

BE IT FURTHER RESOLVED, this ordinance shall take effect immediately upon adoption, publication and filing according to law.
