

ORDINANCE NO. 2016-10 (1154)

AN ORDINANCE OF THE BOROUGH OF LAVALLETTE, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 55 OF THE CODE OF THE BOROUGH OF LAVALLETTE ENTITLED "SOLID WASTE" AMENDING SECTION 55-11 ENTITLED "BULK TRASH REGULATIONS"

BE IT RESOLVED, by the Governing Body of the Borough of Lavallette that Chapter 55, § 55-11 Bulk Trash regulations be supplemented to read as follows:

§55-11. Bulk trash regulations.

- A. The Borough Council shall from time to time, by resolution, establish a fee schedule and a schedule of dates for the collection of bulky solid waste items from residential property by the Department of Public Works. The fee is specifically to cover the cost of the service of picking up the item and the ultimate transportation and disposal of same.

55-13. Recycling materials designated.

- A. (6) Electronic waste: May be picked up by the Department of Public Works upon the resident of the property calling and scheduling an appointment for the pickup. The Borough shall from time to time set the cost of the pick up by resolution. The initial costs for a Television are \$10.00.
- B. Computer, monitors, VCR's, printers, radios, laptops and telephone equipment shall be \$5.00 per item. (Subject to a change in the fee schedule set by Council.)

The Borough shall not accept electronic waste at the Recycling Center. Residents of the Borough may either have same picked up by the Department of Public Works or they may transport it to the County Recycling Center where they can dispose of it at no cost.

NOW, THEREFORE BE IT RESOLVED, that the Fees set forth above are hereby established;

BE IT FURTHER RESOLVED, if any section, paragraph subsection, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subsection, and clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

BE IT FURTHER RESOLVED, all ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed as to such inconsistency.

BE IT FURTHER RESOLVED, this ordinance shall take effect immediately upon adoption, publication and filing according to law.
