**Resolutions to be Memorialized:**

Application #1-10, Richard and Debra Rovito, 123 Elizabeth Ave., Block 61, Lot 6

A motion was made by Mr. Zylinski, seconded by Mr. Calderaro, to approve the application for expansion of a non-conforming use to include only the modification to height of the second floor bedroom to permit the construction of egress windows subject to the following conditions: (1) the concrete pad must be removed so that the ground coverage is reduced to 1.8 percent. (2) applicant must re-side the entire house, garage and roof to create a uniform appearance; (3) applicant must submit amended plans in accordance with the amendments made to the variance application as discussed at the hearing. All other requests for expansions of the existing house and use were withdrawn by the applicant. On roll call: Messrs. Zylinski and Calderaro, yes-, Mrs. Zaccaria, yes-, Mr. Palinsky, yes-, Mr. Howard, yes. Motion carries.
