Review & Approval of Minutes:

Case # 3-09/2-11 – Nicholas Moore – After reviewing a Resolution of Approval for a 3 month extension of time within which to obtain construction permits from September 28 to December 28, 2012, a motion to approve the resolution was made by Mrs. Filippone; seconded by Mr. Baginski with all present voting in favor.

Mrs. Filippone informed all present that the memo from Christopher Parlow dated September 18, 2012 accompanying Ordinance No. 2012-12 (1111) should read: “The Ordinance will be considered for adoption by the governing body during their meeting of November 17, 2012.” Mrs. Filippone reviewed the changes and additions affecting the oceanfront properties and the Area, yard and building requirements for corner lots located on West Point Island.

Mr. Calderaro asked if the Zoning and Building officials had an opportunity to review these changes and additions; Mrs. Filippone answered that they had, and the reaction was positive.
