CALL TO ORDER: Mayor Walter G. LaCicero, presiding

ROLL CALL: Council Members Borowski, Lamb, Zalom, Stogdill, Finter and Filippone

Councilman Stogdill was absent.

READING OF THE OPEN PUBLIC MEETINGS ACT STATEMENT: Notice of this meeting was published in the Ocean Star on January 10, 2025. Notice was also posted on our municipal bulletin board and municipal website.

MOMENT OF SILENCE: The Mayor asked for a moment of silence for long-time resident Helen Calvanico of Bay Blvd. who passed away recently.

PLEDGE OF ALLEGIANCE: Councilman Lamb led us in the Salute to the Flag.

MAYOR'S WELCOMING STATEMENT: The Mayor welcomed everyone to tonight's meeting. He stated he has been attending the weekly meetings regarding the beach replenishment updates. There have been some mechanical issues but they are still on schedule and will give us another update this week.

APPROVAL OF MINUTES:

A Motion to approve the minutes was made by Councilman Finter. The Motion was Seconded by Councilwoman Filippone.

Mr. Burns stated that he is in the process of reviewing some of the Borough's ordinances at the request of the Ordinance Committee for some potential amendments. Some of these ordinances are regarding LOSAP and a potential question to be put on the ballot for the general election, plastic cutlery being given out at food establishments, open fire pits and chimneys, tents and ball playing on the beach. Construction code for back bungalows and/or back houses allowing homeowners to install central air in back houses/bungalows without having to go to Planning Board.

Mr. Bennett stated that regarding all facility use applications we will be requiring starting this year mandatory submission of gross receipts with their $12 \frac{1}{2}\%$ of proceeds and they will have to follow the rule of submitting payment within 10 days after the last day of their use of our facilities. If they do not comply with this, they will not be approved for any facility use applications in the future.

Ordinance No. 2025-04 (1268) Ordinance to Exceed the Municipal Budget Appropriations Limits and to Establish a Cap Bank

Mayor LaCicero stated that this ordinance is done every year in conjunction with the budget. We never have had to use it but our Auditor always requires us to adopt it just in case.

A Motion to introduce this ordinance was made by Councilman Lamb. The Motion was Seconded by Councilman Finter.

Vote: Council Members Borowski, Filippone, Zalom, Finter and Lamb voted Yes. The Motion Passed.

Public Hearing and Final Adoption is scheduled for April 21, 2025.

General With Action:

a) Nicole Zambell/226 Bryn Mawr Ave/proposing Mayor and Council's consideration of small rectangular aluminum street signs (24"x6") be put at the foot of each beach ramp.

Nicole Zambell, 226 Bryn Mawr Avenue stated that she is proposing these beach signs to be placed at the base of the beach walkovers mostly for the safety of the children, seniors and tourists. When I lived in Ocean Beach we did this and it saved us in a lot of emergency situations. Also, there are special stainless steel screws that are tamper proof to prevent them from being stolen and we mounted them up higher as well.

Councilman Lamb stated that our Public Works has already started this project once we received your letter because we also thought it was a great idea. They will be using vinyl and aluminum as well as the stainless steel screws.

Ms. Zambell thanked Mayor and Council for being so receptive to this idea and for the quick response.

- b) US Dept. of Interior/Fish and Wildlife Service/Ryan Braham, Field Supervisor/Protective Measures of the federally listed (threatened) plant seabeach amaranth that is on a portion of our ocean beach pursuant to the Endangered Species Act of 1973.

INTRODUCTION OF THE 2025 BUDGET: (Budget Resolution)

Mr. Burns read the budget Resolution 2025-115

Mr. Bennett stated that our CFO and Borough Auditor will be at the Council Meeting on May 5th for the Adoption and Public Hearing. The biggest issue with this budget is the health insurance which is becoming a very big expense each year as well as the pension plans. We increased the amount of appropriations from surplus of \$50,000. A home in Lavallette with a value of \$900,000 taxes increased a little over \$100 for the year. The total appropriations has actually gone down so we are still in a good place right now.

A Motion to introduce the budget was made by Councilman Finter. The Motion was Seconded by Councilman Lamb.

Vote: Council Members Borowski, Filippone, Zalom, Finter and Lamb voted Yes. The Motion Passed.

Public Hearing and Final Adoption is scheduled for May 5, 2025.

UNFINISHED BUSINESS:

Mr. Bennett stated that the history book meeting was very productive and a good turnout. We are making progress.

Mayor LaCicero stated that with the Westmont Shores curb project, each homeowner will be able to choose where they want the curb cuts to go for their cars. Each curb cut runs 12 feet.

Councilwoman Filippone stated that there will be another memorial bench program starting soon. We already have a list for this and we will go in order of the list. We also will be doing our own projection and outdoor theater for our movies on the bay this year and we will be having our own staff in charge of showing it. We also will be getting the movies from the library at a cheaper rate than what we were paying from another company and we will stay be paying the copyright fees to ASCAP still. All in all we will be saving a decent amount of money each year.

Mr. Bennett stated that a new fence will be going up by the shuffleboard and basketball courts and a little bit of work will be done on the pickle ball courts as well.

NEW BUSINESS:

There was no new business.

COMMENTS OF THE MAYOR AND COUNCIL MEMBERS:

Councilman Finter stated that the County Connection bus will be in Lavallette for all the events going on in the summer and they have a lot services available to the public. Also, Public Works still need to know what type of water pipes are under your house so please get that done.

Councilwoman Filippone stated that we have about 64 benches that we can order and about \$44,000 to spend. We will process this year and if you purchase a bench you can select a general location. Right now we have about 40 that need to go by the gazebo and the rest of them, roughly 24 benches will go to each beach access point. There are pine trees over by the shuffleboard courts that really need to be replaced with some type of evergreen trees. There are some cracks still in the pickle ball courts because of the preparation at the time. It seems that some of the public tried to repair them which caused more of an issue now. No one should be repairing our facilities except our Borough employees or a company we hired to do so.

Councilman Lamb stated that we did find a company for this and at a reasonable price so it will be done soon.

Councilwoman Filippone stated that there is an older bench over by the pickle ball courts that someone decided to put a plaque on. This bench was not purchased nor was this plaque so this plaque was removed. Under no circumstance can anyone put a plaque on any benches in the Borough of Lavallette without Borough approval. Only approved donated benches get plaques on them.

COMMENTS FROM THE PUBLIC:

Mary Heveran, 2204 Grand Central Avenue thanked Mayor and Council for approving the beach signs for the walkovers. Would these signs be going up for this year?

Mayor LaCicero stated that they will be up for this year before the season starts.

Mark Speaker, 111 Brown Avenue questioned when the calendars were being sent out.

Mr. Bennett stated that the calendars are at the Borough Hall and you can pick them up once you receive your post card and bring it to the Borough Hall to pick it up.

Mayor LaCicero stated that he is confident that once a new Governor is elected there will be more drummed up support against this and it will go away.

EXECUTIVE SESSION:

There was no executive session.

ADJOURNMENT:

A Motion was made by Councilman Lamb to adjourn the Council Meeting. The Motion was Seconded by Councilman Finter.

Vote: All of Council was in favor. The Motion Passed.

The Council Meeting was adjourned at 8:23pm.
