Councilman Shenewolf thanked Mayor and Council for supporting his appointment as Councilman. He is eager to get to work and follow in Councilman Lamb's footsteps.

Councilman Borowski stated that summer hasn't even officially begun yet and already the Lavallette First Aid has had 100 calls. Some of them have been with bicycles who are going the wrong way and cars are only looking the way the cars are coming. When in the intersections of both highways force yourself to look both ways please.

Councilman Stogdill stated that some police presence up on the beach for Memorial Day Weekend was great and definitely helped with keeping people in order.

COMMENTS FROM THE PUBLIC:

Robert Cione, 19 Ortley Avenue stated that he would like Ortley Avenue to be one of the surf beaches instead of Bryn Mawr Avenue because it's better for the surfers than Bryn Mawr.

Councilman Stogdill stated that he can reach out to the Lifeguard Captain Jack Caucino and discuss it with him.

Judith Josephs, 114 New York Avenue stated that one of the artists of the beach signs stated that winter signs are also needed. Also, we both walked the boardwalk and noticed that the summer signs are in need of repair. Fifteen of them are blank, 8 are faded and 2 are not legible and Trenton Avenue doesn't have a sign at all.

Councilwoman Filippone thanked Attorney Chris Tretola for filling in for Mr. Burns.
